Those attending the September membership meeting learned about an organization called <u>Welcome</u> <u>Neighbor STL | Community Support Group for Refugees</u>. They were our guest speakers that evening. This organization partners with refugee and immigrant families helping them adapt to their new country through English classes, tutoring and organizing supper clubs/catering events lead by immigrants who provide meals for the community as a way to fundraise. One of the programs they offer is cooking classes for outside groups. Attending a cooking class helps them raise funds for the immigrant/refugee families. **LET'S Do IT!**

We need to have 15 participants so please invite any family/friends that may be interested as well.

The Service Committee has selected a Syrian menu. Refugee Syrian women will teach us how to prepare a meal from scratch. Of course we will be eating the meal after preparing it!

The menu includes *Hummus* made of chickpeas, garlic, lemon, tahini and olive oil served with pita bread and *Middle Eastern Ouzi Rice* with vegetables, ground beef, aromatic spices, basmati rice, pine nuts, peas, carrots, onion and ghee.

The cost per person is \$50. Much of the proceeds go toward helping refugee/immigrant families.

This will be a great opportunity to introduce friends to Zonta and for the newest members and longer serving members to get to know each other better.

State Legislation Update

Well.... it seems that there is much support in helping to make change in Missouri! Zontains on the district and international levels are pitching in. Unchained at Last has also been included on emails that are starting to "fly". In the process, two other pieces of legislation were brought to light that might peak your interest.

Just How Does a Bill Become Law?

SB767 - This bill would raise the age for marriage in Missouri. Under the current law, 16 and 17-year-olds are allowed to get married with parental consent. Marriage between a minor and anyone 21 or older is prohibited. SB767 would prohibit issuing marriage licenses to anyone under the age of 18 under any circumstances. Under the identical bills, co-sponsored by Republican Sen. Holly Thompson Rehder of Scott City and Democratic Sen. Lauren Arthur of Kansas City, Missouri would join 10 states that have banned child marriage. SB767 was voted out on 2/5/24 and was placed on the informal calendar - Senate Bills for Perfection on 3/7/24.



SB1706 - This bill would change a conviction for purchase or attempt to purchase sex from a class B misdemeanor to a class E felony. The conviction would carry a sentence of prison time for up to 4 years. It is an attempt to combat sex trafficking. The sponsor, Rep. Jeff Myers, a Republican, is from Warrenton, MO and is a former highway patrolman. It was heard and voted out of committee and is now on the House calendar for debate.



HB2402 - Missouri is one of 4 states that doesn't allow a pregnant woman to be granted a divorce while pregnant. She can file for divorce however an order granting the dissolution cannot be issued until the baby is born. Homicide (most often by the spouse/partner of the pregnant woman) is the 3rd leading cause of death of pregnant women in Missouri. This bill would change Missouri law to allow judges to enter a judgment of dissolution regardless of pregnancy status. It has been heard in committee but has not yet been voted out. The bill was filed by Rep. Ashley Aune, a Democrat from north Kansas City.
